

ANNOUNCEMENTS

The Friends of the Pasadena Public Library is in the process of organizing a volunteer program to assist the libraries in the areas of cataloguing, research, sorting... and other library related tasks. Neighbors in the vicinity of the intersection of Nithsdale Road and South San Rafael have recently approached the City of Pasadena to ask for the installation of a stop sign on South San Rafael at Nithsdale. A neighbor child was recently seriously injured by a speeding car coming south on South San Rafael from the freeway. The neighbors would like your support for the stop sign.

At the urging of Pasadena, Caltrans has placed the construction of sound barriers on the Route 134 Freeway in the San Rafael area in the construction budget for the next five years. The budget will be considered and approved by the California Transportation Commission in the spring.

Neighbors along Palmetto Drive, Bellevue Street, and Waverly have been meeting and working with city staff regarding a possible "zoning adjustment" on those streets. There may be a

short "interim study district" formed to facilitate any needed changes. The City Board of Directors will consider the matter at the board meeting on Tuesday, November 14, 1978. For further information call, Tom Thomas at 792-2672.

Pasadena Heritage has recently submitted a nomination of the Civic Center District to the State Office of Historic Preservation with the intent that the area covered will be listed in the National Register of Historic Places. The District nomination includes the Pasadena City Hall, Public Library, Civic Auditorium, the Post Office, the YMCA and YWCA, the Turner Stevens Mortuary, the American Legion Building, Police Station and Memorial Park. The downtown section of Pasadena was planned carefully and represents a good example of the City Beautiful Movement of the early part of this century. Members of Pasadena Heritage will be pleased to answer questions about the nomination at 793-4378.

PLANNING UNDERWAY TO PRESERVE THE ARROYO

The Planning Commission and the City of Pasadena is in the process of considering an "Interim Arroyo Seco District" in the general area bounded, as of this writing, by Oak Grove Drive (Devil's Gate Dam), Linda Vista Avenue, San Rafael Avenue, south city limit and Arroyo Boulevard. The interim study district, to be established for a period of six months, will review present ownership of land, zoning patterns, plans for construction of buildings and grading on public and private property in the Arroyo Seco. Further information may be obtained from the office of the City Planning Commission, Room 207, City Hall (577-4152).

The Vista Del Arroyo site, recently declared eligible for inclusion on the National Register of Historic Places, continues to be in the news. It is currently owned by the General Services Administration of the Federal Government. Judge Richard Chambers of the United States Court of Appeals has opened discussion with GSA about the possibility of using the main hotel building of the Vista del Arroyo site as a Court of Appeals. Judge Chambers is well known for his fine restoration of historic court buildings in both San Francisco and Portland. A use for the Maxwell House—the

mansion on Grand facing Green Street—has not been determined. Some thought has been given to demolishing the surrounding bungalows to make way for additional parking. WPRA has a committee following carefully these latest developments of the Vista del Arroyo site. Should you wish more information or want to express your opinion, call George McQuilkin at 793-7733.

FOR YOUR INFORMATION

Neighborhood Watch Program: We are all concerned with crime, particularly burglaries, in our neighborhood. It may be of some comfort to you to know that the Pasadena Police Department is also alarmed and has an on-going program to help reduce our homes as potential burglary targets. Their methods consist of (1) improving physical security of each house, (2) increasing the probability that the criminal will be caught by encouraging citizens to be suspicious of unusual circumstances in their neighborhood, (3) improving the lines of communication between the home owner and the police and (4) increasing the likelihood that stolen property will be returned by proper identification of items.

Both the Police Department and W.P.R.A. encourage each neighborhood block to contact Agent Curtis, who will help you formalize a program for your specific area. His telephone number is 577-4550.
