

# MESSAGE FROM WILLIAM J. BOGAARD, MEMBER, BOARD OF DIRECTORS, CITY OF PASADENA

City Board Acts to Protect "Old Pasadena"

By adopting an Urban Conservation Zone, the Pasadena Board of Directors has taken final action in establishing an historic district on West Colorado following a hearing on September 18. This represents the last major step in a planning process which has been underway for more than three years.

As a result, the old town area is expected to be maintained and improved over the years as an historic preservation area and as a revitalized commercial district. It is suggested that Old Pasadena will be a valuable compliment to the modern Plaza Pasadena, which is scheduled for completion in 1980.

The protections that have been established will

restrict demolition of existing buildings, impose design requirements for rehabilitation and new construction, provide parking through assessment districts, and phase-out signs which do not conform to the historical guidelines of Old Pasadena.

Creation of this district was initiated by property owners in the area and was supported by cooperation on the part of City Government.

Director Bill Bogaard has spoken to Judge Chambers regarding the traffic and parking problems that may result from the activation of the Vista Del Arroyo Hotel for the use as a U.S. Court of Appeals and Federal offices.

Remembering his commitment to W.P.R.A., Judge Chambers is strongly supporting efforts by the City to assure that tenants of the tower (main hotel) other than the Court do not create undue traffic or excessive parking requirements.

#### Important Meeting

Officials from the General Services Administration and the Department of the Interior will be meeting with W.P.R.A. neighbors at La Casita del Arroyo on October 12 to discuss the plans for the Vista del Arroyo Hotel complex. A meeting will be held from 1:30 - 3:30 in the afternoon and again in the evening from 6:00 - 9:00. Neighbors are encouraged to attend either one of the meetings and to express any concerns.

GSA officials have indicated a strong interest in working with the neighborhood on this project. La Casita del Arroyo is at 177 S. Arroyo Blvd., Pasadena.

#### FOR YOUR INFORMATION:

W.P.R.A. member Robert Hardie is in the process of collecting signatures on a petition to be sent to Caltrans requesting landscaping on Caltrans property at the end of residential streets between Del Mar and California. There is a continual weed problem on the residential streets to the west of the California Blvd. off-ramp of the Long Beach Freeway. Members are encouraged to sign the petition requesting immediate landsdaping of the Caltrans property. Mr. Hardie can be reached at 793-5880. ## NOTES FROM THE W.P.R.A. OPEN BOARD MEETING

A W.P.R.A. Open Board Meeting was held at Mayfield Senior School on Wednesday, September 26. There were approximately 100 persons in attendance.

In accordance with the provisions of Article IV, Section 3 of the By-Laws of W.P.R.A., the process for nominating directors to be elected at the annual meeting in February 1980 has commenced. The By-Laws provide that:

"Directors shall be nominated by the Nominating Committee which shall be the President and four (4) other members of the Board whose terms of office do not terminate, which other members shall be chosen by the majority vote of the full Board of Directors and shall be removable at the will of the majority vote of the full Board."

At the meeting of the Board of Directors which was conducted on Wednesday, September 26, 1979, the Nominating Committee was selected and is composed of the following members of the Board.

The By-Laws also provide that:

"Directors may also be nominated by written nomination filed with the President at least ten (10) days before the annual meeting and signed by at least ten (10) members. The Nominating Committee shall give particular attention to nomination of directors to give balanced representation to the various geographic sections of the area designated herein for Association membership."

The area designated for membership in the Association is from Colorado Boulevard south to the city line and from Fair Oaks Avenue west to the city line.

Members of the Association who are either interested in serving on the Board of Directors or who wish to propose nominees for the Board are requested to contact one of the members of the Nominating Committe.
